If tuition is not paid, including the late fee, by the third week of class my dancer will be removed from class. As well, if the costume payment isn't made by Dec. 13th, my account will be charged a late fee of \$10 per costume. For any checks that are returned, my account will be charged a \$25 NSF fee. If I choose the monthly payment plan, I fully agree to pay seven full payments, as agreed and signed upon. If my dancer withdraws from classes, the remaining months' worth of payments will be made. **There are NO CLASS REFUNDS given for any reason.** If class is cancelled, due to weather an email will be sent out to announce the cancellation. If Sun Prairie Schools are closed or dismiss early due to weather there will not be classes that evening. A phone call **will not** be made to me. Snow days and holidays are not classes that are refunded however dancers are welcome to attend another class within 2 weeks of a weather related cancellation as a make-up class. Lastly, it is fully my responsibility to read any and all newsletters. Newsletters are emailed to our families. Additionally, recital is not mandatory. ~IMPORTANT DUE DATES~

Session I tuition is due Sep. 1st. If payment is received after Sep.17th, a \$10 per class late fee will be incurred.
Costume fees are due Dec. 1st. If payment is received after Dec. 13th, a \$10 per costume late fee will be incurred.
Session II tuition is due Dec. 1st. If payment is received after the Dec. 13th, a \$10 per class late fee will be incurred.

~CLASS ATTIRE~

Ballet/Tap, Girls: Any style leotard, any style ballet skirt if desired, and pink, white or black tights.

Jazz, Girls: Any style leotard, jazz pants or skirt, and pink, white, or black tights or socks.

Ballet/Tap/Jazz, Boys: Black sweatpants or running pants, plain style tee shirt, and socks if desired.

~PROPER DANCE SHOES~

Girls: Pink Leather Ballet Shoes, Tan Tap and Tan Jazz Shoes

Boys: Black Leather Ballet Shoes, Tan Tap and Tan Jazz Shoes

~MISSED CLASSES~

Dancers are welcome to make up a missed class by attending any of our comparable classes during the week. Just let the instructor know.

~TUITION~

If you are registering during early registration you must pay tuition due to qualify for the applicable discounts. All other tuition payments must be made by the 2nd week of the session. If tuition is not paid by September 11th, your account will be charged a \$10 per class late fee. If tuition is not paid, including the late fee, by the third week of class your dancer will be removed from class. If you choose the monthly payment option, you're fully will pay seven full payments by their due date, as agreed and signed upon (see additional sheet). If your dancer withdraws from classes, the remaining payments must be made. There are no class refunds given for any reason.

Our Spring Recital is a wonderful show! Each class gets an awesome costume that is purchased (**cost due by Dec. 1st**). Our spring show is traditionally scheduled for the second weekend in May, though it fully depends on the auditorium's availability! The date will be confirmed by February. Tickets, which will go on sale in April, are sold to offset the cost of the auditorium. We will also have a full costume & make up dress rehearsal at the auditorium the week before the show.
